Prospective bidders must be **Philgeps Platinum Membership** registered and have the experience in undertaking **similar** and **not similar** project **within two (2) years, 2019-2020** with a total amount of at least **25%** of the proposed project for bidding and have key personnel and facilities available for the implementation of the project. The list of minimum requirement is indicated in the Eligibility forms. Supplier with existing Liquidated Damage for ongoing BFAR projects is not qualified in buying bid documents. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

Bid documents will be available only to prospective bidders upon payment of a non-refundable amount of **P5,000.00** to the BFAR-10 Cashier.

The Bureau of Fisheries and Aquatic Resources -10 reserves the right to reject any or all bids as well as to waive any defect or informality in the submitted bid documents. It also reserves the prerogative to accept any bid it may consider as most responsive and advantageous to the government.
